ORDERS SOUGHT

On 25 November 2009 at 10.00am the plaintiffs will move the Supreme Court of New South Wales, at Queens Square, Sydney, for the following *ex parte* interlocutory orders:

- 1. The plaintiffs have leave to file in Court today the following documents before the Honourable Justice Bergin, Chief Judge in Equity, namely:
 - (a) a notice of motion dated 25 November 2009;
 - (b) an affidavit of Terence Louis Goldberg sworn on 24 November 2009;
 - (c) Exhibit TLG1 to Mr Goldberg's affidavit;
 - (d) an affidavit of Terence Louis Goldberg sworn on 25 November 2009;
 - (e) an affidavit of the Reverend Patricia Cleary sworn on 24 November 2009;
 - (f) a summons commencing these proceedings;
 - (g) proposed short minutes of the orders to be made *ex parte* today.
- 2. The plaintiffs have leave to make the notice of motion referred to in paragraph 1(a) returnable before the Honourable Justice Bergin, Chief Judge in Equity, instanter.
- 3. The plaintiffs ensure that the fifth defendant Norman Power, is personally served with a sealed copy of each of the summons commencing these proceedings, the notice of motion filed in Court today, the affidavit of Terence Louis Goldberg sworn 24 November 2009 and Exhibit TLG 1 to it, the affidavit of Terence Louis Goldberg sworn on 25 November 2009 and the affidavit of Patricia Cleary sworn on 24 November 2009, together with a sealed copy of these orders, on or before 10:00am on 26 November 2009.
- 7. An order that the requirements of the Rules for effecting service of the Court process commencing these proceedings and any other Court process in the course of these proceedings on the sixth defendant, Enmore Spiritualist Church Inc (the Church), be and is hereby excused.
- 8. The plaintiffs have liberty to enter these orders in the Registry forthwith.

On 1 December 2009 at 10.00am the plaintiffs will move the Supreme Court of New South Wales, at Queens Square, Sydney, for the following *inter partes* interlocutory orders:

- 9. Each of the first, second, third, fourth and fifth defendants, by themselves, their servants and agents and licensees, be and are hereby restrained, until further order of the Court, from convening or otherwise purporting to convene or hold a Special General Meeting or indeed any other meeting of the financial members or non-financial members of the Enmore Spiritualist Church Inc (the Church), whether in accordance with the notice of the calling of such a Special General Meeting given on 14 November 2009 to all financial members of the Church or otherwise, and whether held at the Church premises at 2 London Street, Enmore, or otherwise.
- 10. Each of the first, second, third, fourth and fifth defendants, by themselves, their servants, agents and licensees, be and are hereby restrained, until further order of the Court, from entering upon the Church premises at 2 London Street, Enmore or from otherwise taking possession, custody or control of any of the Church property which is not presently in their possession or under their custody or control.

- 11. Each of the first, second, third, fourth and fifth defendants by themselves, their servants, agents and licensees, be and are hereby restrained, until further order of the Court, from issuing letters, notices, circulars to (including circular letters), or otherwise communicating with, any members of the Church in which the defendants make adverse allegations against, or raise any questions about the propriety of the conduct of:
 - (a) the first plaintiff, Patricia Cleary, in respect of the performance of her role as the Church's Minister, or as its president, or as a member of its Committee or of the Church generally, or in respect of the conduct of the Church finances or alleged non-receipt by the Church of Church expenditure; or
 - (b) any of the other plaintiffs in respect of their capacity as members of the Committee of the Church,
