*Re: Criminal conduct*

I write to formally record that you have not provided any response to my letters of 11<sup>th</sup> October 2018 and 26<sup>th</sup> October 2018 (copies **attached**), however, your consistent refusal to respond to correspondences outlining your improper conduct is nothing new.

I think at this stage that we can quite fairly and properly state as fact that you are covering up not only issues of serious misconduct, but also acts of criminality. The outstanding question is why you are doing so.

Given that you have been advised on numerous occasions of the illegal activities that have taken place and your obstinate refusal to take any form of corrective action, your own actions must be a deliberate attempt to protect those who carry out such acts of wrongdoing.

I refer you once more to the Application for Assessment of Solicitor/Client Costs which Terence Goldberg of Turner Freeman Lawyers filed with the Supreme Court of NSW on 23<sup>rd</sup> June 2010 in order to create a fraudulent debt against a party for whom he did not act and who was not his client. As you well know, such document contains a multitude of false statements.

At the rear of such Application exists a purported costs agreement between Turner Freeman's four actual clients and also with Enmore Spiritualist Church Incorporated. This document **must** have been fraudulently created after the fact. Such would be obvious to a man of your considerable experience.

As you are well aware, if Enmore Spiritualist Church Incorporated had been Turner Freeman's client, it could neither have been a defendant in Supreme Court proceedings 2009/00291458-001, nor could it have been an unrepresented party in those same proceedings (proceedings then known as 5454/2009 before change in Court system), with Turner Freeman having acted for the four plaintiffs in the matter.

As you also well know, all Court documentation states quite clearly that Enmore Spiritualist Church Incorporated was both a defendant and an unrepresented party (in such proceedings), and yet, you have never questioned Terence Goldberg on this obvious anomaly, and neither have you questioned Mr Goldberg on the many other existing anomalies which have been repeatedly brought to your attention relating to same.

Remaining with the aforesaid Application for Assessment of Solicitor/Client Costs, I come to entry 487 in the Turner Freeman invoice as attached to that Application. Item 487 of such states "19/11/09, Preparation, arranging typing and checking form of Authority to appoint Jon [Lindsay] as agent for purposes of dealing with firm".

The above named Jon is the same Jon Lindsay who, while claiming to be a creditor of Enmore Spiritualist Church Incorporated, voted to wind up the incorporated association, and it is also Mr Lindsay's given home address to where the remaining funds belonging to the association in question have found their way, with Terence Goldberg's direct assistance.

Mr Lindsay is also the registered Public Officer of the sham entity as created by Terence Goldberg, with that same entity acting as a receptacle for the said funds, with such sham entity also sharing Mr Lindsay's given home address.

Quite pertinently, you have also been made aware of Mr Lindsay's previous criminal history. Despite such, and despite also the obviousness of the fraud as laid before you, in correspondence to me of 25<sup>th</sup> July 2017, and due to my formal request that you abide by section 465 of the *Legal Profession Uniform Law NSW*, you state:

*"...I have not reported Mr Goldberg to the Police as I do not believe there are reasonable grounds to suspect Mr Goldberg has committed an offence."*

Again, the frauds are obvious, as are the cover ups, and cover ups that certain others around you are quite content to overlook. It is also clear that Terence Goldberg has been able to operate with abandon, quite obviously in the knowledge that people such as yourself are prepared and willing to protect both him and his firm.

As I stated above and have requested of you previously, what are your reasons for covering up this obvious act of misconduct and fraud, as well as subsequent other matters of serious misconduct? What has incentivised you to do so?

I copy this letter to the External Liaison Unit of the Professional Standards Command of the NSW Police and also to the Law Enforcement Conduct Commission.
